2. AUTOUNION CORFU, Represented by VasiliosVasiliou, AntoniosZygouris&Parga Hire (ZIGOURIS S.A.) is the exclusive master for car rentals in the area of Sivota, Parga, Ammoudia&Preveza.

THE FOLLOWING HAVE BEEN MUTUALLY DECIDED AND AGREED

The contract will endure for a period of two years 2016& 2017.

The contract is valid for the destination of Parga, Sivota (Thesprotia), Ammoudia, Preveza.

At check in of the rental, client should have a credit card as deposit to cover for all extra charges.

Clients must pay all invoices which concern local sales, in total directly to the station.

GENERAL TERMS CONDITIONS RATES

The rates are quoted are Net, Non-Commissionable, non- Discountable and are valid only for the reservations from abroad.

The rates include: Unlimited mileage, Collision Damage Waiver (CDW), Theft protection Coverage not valid if vehicle is taken outside Greece (TPC), Third Party insurance (TPI), Airport Service Charge (Asc), Value Added Tax (Vat),

Fire protection, Delivery / Collection.

Voucher should specify what the rates sold to the customer include.

Any unused portion of the voucher is non-refundable

Third Party insurance covers up to 100.000 Euro for damage to Property and also 500.000 for death or injury.

Any Change of Vat or local tax as well as any substantial increase of insurance costs will affect the rate as quoted.

Any rental beginning in Low Season and Ending in High or vice versa will be charged pro-rata.

Driver must be 21 years old for groups A,B,C,D and 23 years old for E,F,G

Ferrying the vehicle is not allowed.

Across the border rental is not allowed.

Groups A,B,C are on free sale (no confirmation required).

All other groups are on request.

EXTRA INSURANCES

The Following additional insurances are optional and may be purchased locally the following daily rates, plus , VAT.

- Full Damage Waiver (FDW) for groups A,B,C, costs 8 € (Plus VAT) daily, excess is 380 € (Plus VAT). For groups D,E,F,G (FDW) is 10€ (Plus VAT) daily, excess is 500 € (Plus VAT).
- Personal Accident Insurance PAI 6 € (Plus VAT)
- Additional Driver(s) 3 € (Plus VAT)
- None of the insurances cover the damage of tires, mirrors, windscreens, car parts underneath the vehicle, any breakage of windows, car interior and damages caused by violation of the Greek traffic law.
